WEST VIRGINIA TOPS NATION IN CONSTRUCTION JOB EMPLOYMENT LOSS

West Virginia continues to lead the nation in the largest percentage of construction jobs lost in a year-over-year period, 13.1 percent drop from April 2014 to April 2015. The alarming factor for this month's jobs report, however, is that West Virginia also leads the nation in the highest total of construction job losses. This is the first time that the state has earned this dubious honor. Between April 2014 and 2015, West Virginia lost 4,400 jobs. The closest state to this number is Mississippi at 3,200 jobs but that only represents 6.3 percent of that state's construction employment. Ohio shed 3,000 jobs in the same period but that is 1.5 percent of that state's construction workforce. West Virginia has ranked dead last in construction employment most of 2014 and all of 2015. These figures are based on an analysis of Labor Department data by the AGC of America.

AGC's analysis shows that construction firms added jobs in 40 states and the District of Columbia. Association officials said that even as construction employment continues to expand, workforce shortages and infrastructure funding challenges threaten future growth. "Construction employment grew faster than overall employment in most states in the latest 12 months, but the industry faces two challenges: a lack of experienced workers in many locations and a risk that funding for highway and transit projects will lapse in the next few months," said Ken Simonson, the association's chief economist.

WEST VIRGINIA PREVAILING WAGE LAW UPDATE

S.B. 361 made a number of changes to the state's prevailing wage statute and went into effect on April 13. State prevailing wage requirements will only apply on state of West Virginia, and its political subdivisions, projects valued at more than \$500,000. The current threshold was \$25,000. Private projects that get public grants will require prevailing wages only if the amount of the grant is more than \$500,000 regardless of the size of the project. The WV Division of Highways and other public owners have placed in documents for upcoming bid openings information on the new law. Bidders should note that the new law does not apply when federal funding is part of the project. S.B. 361 moves the authority for determining wage rates from the Division of Labor to Work Force West Virginia. Work Force, in cooperation with both WVU and Marshall University, is charged with creating a new methodology by June 1, 2015 to determine what rates prevail. New rates must be out by July 1 but could be extended to September 30 if more time is needed to determine rates. Work Force is close to having a draft of the methodology to present to the Joint Committee on Government and Finance. CAWV members will be asked to review the draft and comment once it is available.

Frequently Asked Questions and Answers for SB 361

Question 1: When does the new prevailing wage law go into effect?

Answer 1: April 13, 2015.

Question 2: What is the West Virginia Code section for the new law?

Answer 2: West Virginia Code §21-5A-1, §21-5A-2, §21-5A-3, §21-5A-5, §21-5A-6, §21-5A-8, §21-5A-10, §21-5A-11 and §21-5A-12.

Question 3: Does the change in the West Virginia state Prevailing Wage law effect the West Virginia Public bidding statute?

Answer 3: No. The state of West Virginia, every political subdivision thereof, every administrative entity including all municipalities and all county board must solicit competitive bids for every construction project exceeding \$25,000.00 in total cost with a few exception such as emergency work.

Question 4: Does the new prevailing wage law apply to all publicly bid construction projects?

Answer 4: Yes.

Question 5: Is there a prevailing wage requirements on publicly bid construction projects with a total project value of \$500,000.00 or less?

Answer 5: There is no prevailing wage requirement on solely state funded construction projects of total value of \$500,000.00 or less. (State and federal minimum wage laws still apply). However, projects that are paid for with federal money, either partially or fully, fall under the Federal Davis-Bacon Act. Therefore, on jobs with federal money whose project value is \$2,000 or more, the higher of the federal prevailing wage rates or the state prevailing wage rates will apply.

Question 6: Where can I find the current prevailing wage rates?

Answer 6: The current prevailing wage rates, as well as several previous years of rates are posted on the West Virginia Secretary of State's web page. The following is a web address for the posting: <http://www.sos.wv.gov/administrative-law/wagerates/Pages/default.aspx>

Question 7: Will the West Virginia Secretary of State continue to post the current prevailing wage rates?

Answer 7: Yes.

Question 8: Does the \$500,000.00 threshold apply to the total cost of the project?

Answer 8. Yes. The total project cost, or in the case of a grant to a private entity, the total grant. A project that may have two or more contracts still requires prevailing wage rates if the total cost of the project is greater than \$500,000 regardless of the cost of the individual contracts.

Question 9. When are the rules related to the Prevailing Wage Act prior to the amendment from the 2015 legislative session repealed?

Answer 9. April 13, 2015.

Question 10. On April 13, 2015, when the rules are repealed, does this mean there is no prevailing wage rates until new rates are determined?

Answer 10. No. Current prevailing wage rates are in place by statute until new rates are established or September 30, 2015 whichever date is earlier.

Question 11. Who will be determining the prevailing wage rates under the new law?

Answer 11. Workforce West Virginia will ultimately decide on the methodology to be used to gather information for the prevailing wage rates. Workforce will work in conjunction with the West Virginia University Bureau of Business and Economic Research and the Center for Business and Economic Research at Marshall University to set the methodology procedure.

Question 12. Is there a cutoff date as to when the methodology must be set?

Answer 12. Yes. June 1, 2015.

Question 13. Is there a review process for the methodology procedure?

Answer 13. Yes. The legislative Joint Committee on Government and Finance will review the methodology being used to determine the prevailing wage rate and will give recommendations to the legislature of any statutory changes needed to clarify the method for determining prevailing wages.

Question 14. Will Workforce West Virginia collect the data necessary to set the prevailing wage?

Answer 14. Yes.

Question 15. Will information that I provide for purposes of calculation of the prevailing wage rate remain confidential?

Answer 15. Yes.

Question 16. Will Workforce West Virginia set the new prevailing wage rates?

Answer 16. Yes.

Question 17. When will the new prevailing wage rates be set?

Answer 17. July 1, 2015. However, if the prevailing wage rates are not set by July 1, 2015, the legislative Joint Committee on Government and Finance may extend the time period for when the prevailing wages are to be set until September 30, 2015. If the extension is given, the wage rates as of January 1, 2015 will remain in effect.

Questions 18. What if the prevailing wage rates are not set by September 30, 2015?

Answer 18. There will be no prevailing wage rates after September 30, 2015 and until new prevailing wage rates are set.

Question 19. What state agency will be enforcing the prevailing wage laws?

Answer 19. The West Virginia Department of Labor. The WV DOL is responsible for all wage enforcement on prevailing wage and other areas of the code such as overtime, minimum wage, etc. The new law also gives WorkForce authority to review payroll documents.

Question 20. Does the new law apply to projects awarded before April 13, 2015?

Answer 20. No.

Question 21. If a project is awarded to a bidder whose bid is less than \$500,000.00, and later a change order makes the project value over \$500,000.00, will the entity awarded the bid be required to pay prevailing wage rates?

Answer 21. No. The \$500,000.00 threshold applies to the total project value before the bid is awarded.

Question 22. Must a project of total value of \$500,000.00 or less be publicly bid?

Answer 22. Yes unless the total project value is less than \$25,000.00.

FAYETTE COUNTY SCHOOL BOND ELECTION SCHEDULED FOR JUNE 13

The Fayette County school bond election has been making headlines for months. The abrupt January closure of Collins Middle School's seventh-and-eighth-grade building has fueled an effort to pass Fayette County's first bond in more than 40 years despite continuing opposition to consolidation. The closure forced the school to send about 400 students elsewhere after also seeing its band building and gym shuttered due to structural issues in the previous months. A majority vote — which could lead to 15 years of increased property taxes, conditioned on the state School Building Authority responding to residents' commitment by pitching in over \$25 million of its own funds — could generate \$66.5 million for several building projects. That would include a new Collins Middle and a new Mount Hope Elementary School, where one classroom has been closed following countywide structural inspections launched in the wake of the issues at Collins Middle.

According to a Fayette school board member, the county has closed 20 — more than half — of its schools in the past 25 years. If the bond passes, Fayetteville High School will close and be converted into a middle school for students 6-8. Students in grades 9-12 will be attend a renovated and expanded Midland Trail High School. Meadow Bridge High School will also close and students 9-12 will move to Midland Trail High. Ultimately the Meadow Bridge complex will become a PK-8 school. Fayette County schools will seek \$38.9 million in the bond election on June 13.

CORRIDOR H TO FOLLOW P3 FUNDING OPTION, GOVERNOR ANNOUNCED

Gov. Earl Ray Tomblin took the opportunity, while helping to cut the ribbon on a new 4.4-mile stretch of Corridor H, to announce the state Division of Highways will use a different financing model to build the next 7.5 miles of the much-talked about highway. Gov. Tomblin has instructed the DOH to put the section from Kerens to Parsons out to bid under the public-private partnership (P3) option. State Transportation Secretary Paul Mattox applauded the decision. "We've constructed a lot of highway on Corridor H over the past 10 years and we currently have a lot of momentum and it's great to see that momentum being carried forward," Mattox told MetroNews.

P3 allows the DOH to choose a contractor, which in turn chooses an engineer on the project. The DOH then evens out its monthly payments for the project over the life of the contract instead of paying a contractor more when more work is being done. Mattox said the option, which is currently being used on the Coalfields Expressway and U.S. Route 35, is working well. He said it's possible with a project like Corridor H the payments would have to be extended beyond the construction. "They are going to be pretty expensive sections of highway," Mattox said. "It may be you may need to extend those payments over a 10 to 15-year period, something of that magnitude, an additional 5 to 10 years beyond the construction period."

The Corridor H Authority supports the P3 option being used on the rest of Corridor H in order to finish the highway by 2020. The last section to open, which was celebrated Thursday, takes the road from Bismarck in Grant County to the Tucker County line. "It's just a beautiful highway. It takes you right in that Mount Storm area where you are coming up and getting on top of the mountain. It's just a gorgeous view, a world-class highway," Mattox said. An additional 10-mile stretch leading into Davis in Tucker County is set to open later this year. Mattox said adding the 7.5 miles announced Thursday will complete all but 25 miles of the road. NEW EPA CLEAN WATER ACT RULE WILL LIKELY LEAD TO DELAYS IN CONSTRUCTION PROJECTS

A major regulatory proposal announced Wednesday by the U.S. Environmental Protection Agency relating to the Clean Water Act (CWA) will require additional burdensome permitting requirements and could be used as a litigation tool by opponents of a project, both of which will result in delays to construction and transportation improvements. In its final "Waters of the United States (WOTUS) rule," EPA attempts to significantly expand the federal government's jurisdiction in additional areas.

In previous comments submitted to the agency multiple times and in congressional testimony, ARTBA has noted that “roadside ditches are not, and should not be regulated as, traditional jurisdictional wetlands as they are not connected water bodies and contribute to the public health and safety of the nation by dispersing water from roadways.” The new rule, however, does not categorically exempt roadside ditches from federal jurisdiction. Instead, the EPA sets forth a myriad of qualifications for a ditch to be exempt from permitting requirements. Such a piecemeal approach will only lead to increased confusion and delays, while also allowing opponents to use the rule as justification for filing lawsuits to stop projects from moving forward, ARTBA says.

One improvement included in the final rule is the clear exclusion of existing quarry and construction pits that the National Stone, Sand and Gravel Association requested. The rule will subject additional areas, such as dry stream beds, to costly and unnecessary permit requirements. “This rule will add significant costs to aggregates producers with little or no environmental benefit,” NSSGA said in a news release. “The increased costs and delays will be passed along to the taxpayers through a higher price tag for infrastructure projects like highways.”

After the Obama administration announced its final rule Wednesday, state officials weighed in on the negative effects of the measure. “The final WOTUS rule announced today is deeply troubling,” said U.S. Senator Shelley Moore Capito said in a statement. “Rather than incorporating input from Congress and concerned Americans, this rule doubles down on overreach and threatens to impede small businesses, agriculture, and coal and natural gas production.” U.S. Senator Joe Manchin condemned the rule and urged action against it, saying it would negatively impact West Virginia’s economy. “This rule will certainly have a significant impact on West Virginia’s economy, hindering businesses, manufacturing and energy production,” Sen. Manchin said. “The bottom line is that no federal agency should go around Congress to control what has not been legislated, especially when its actions will harm economic growth.”

U.S. Representatives Evan Jenkins, Alex Mooney and David McKinley have also condemned the rule. AGC of America and other industry leaders will continue to work with leaders in Congress on possible legislative solutions. Potential litigation to stop the rule from taking effect in its current form will also be explored.
