HOUSE COMMITTEE PASSES BUY AMERICAN BILL

The House Industry and Labor Committee Wednesday voted out H.B. 4168, the Buy American bill. The bill was amended to include many of the onerous requirements that had been previously removed from the introduced bill. The committee substitute requires all public agencies to require a Buy American Provision (BAP) in contracts over \$500,000. Contractors would have to get a waiver, “with sufficient evidence in support of their application,” to use foreign products. The waiver would be granted only if the product is not produced in sufficient quantity in the United States or exceeds the cost of a comparable foreign-made product by more than 10 percent of the cost of the item. The public entity accepting bids shall have the authority to request that vendors provide, “within 5 business days of the request, any documentation that the contracting authority deems necessary to verify compliance with the law.” The WV Division of Labor, who has no experience in designing, advertising, awarding or administration of public construction contracts, will be the agency administering the Buy American law. The bill now goes to the House Finance Committee. **CAWV members will receive a CAWV Legislative Alert outlining the numerous objections to this bill, and particularly to the punitive language included in the bill. All members will be requested to contact their legislators.**

A number of other issues affecting the construction and design industry are still in play, including diverting funds from the State Road Fund and WV Infrastructure Fund to help balance the state's general budget, the OSHA 10-Hour safety bill, a mechanics' lien bill, a bill to modify the state Purchasing Division's change order process, a bill regarding certification of HVAC workers, and the False Claims Act legislation, among many others.

The Legislature has reached the half-way point in this year's 60-day legislative session and much of the time has been spent on hearings and developing bills to address the storage tank leak that shut down water service in a nine-county region. Lawmakers will have to work quickly to get other legislation through the committee process. CAWV members should look for future CAWV Legislative Alerts and be ready to respond accordingly.

PROMISED PRESIDENTIAL EXECUTIVE ORDERS IN STATE OF THE UNION ON STREAMLINING PERMITTING PROCESS

During last Tuesday's State of the Union, President Obama announced a host of planned executive orders. Most pertinent to the construction industry is to streamline the permitting processes for construction projects. The president declared his intent to streamline the permitting process for key construction projects. Again, however, he did not provide any significant thought on how he would do so. The president did previously sign [Executive Order 13604 in 2012](#) on improving performance of federal permitting and review of infrastructure projects. In 2013, he also put forth a [presidential memorandum](#) to further implement that executive order. Such endeavors are a step in the right direction. But, while these documents instruct federal agencies on how to better coordinate their permitting efforts, they do not substantively address the host of environmental laws that enable federal agencies to drag out project permitting and study processes for years and even decades.

CAWV MIDYEAR MEETING HUGE SUCCESS

The CAWV Midyear Meeting, held January 24 – 29 at the Frenchman's Reef Resort in St. Thomas, was highly successful based on members' response. Informative business sessions and networking opportunities highlighted this year's meeting which attracted over 250 members. The meeting began with a Board of Directors meeting followed by Building, Highway and Utilities Division meetings. Much of the discussion centered on legislation that affects all contractors, including the OSHA 10-Hour bill, the Buy American bill, funding, and possible funding cuts for infrastructure projects. The General Business Sessions were at capacity as members learned about CAWV's partnership program with BrickStreet Insurance, the association's new educational programming, actions of the West Virginia Legislature, financial market trends, tax implications of ObamaCare, design-build in the public sector, how the contract approval process works through the state's Attorney General's office and the CAWV's affinity programs that save members money.

Opening the Monday General Business Session were Lisa Teel and Allan Williams of BrickStreet who spoke of the different generations that comprises today's workforce. "Employers need to be flexible in developing return to work programs for injured workers," they stated. "What motivates a Baby Boomer is different than a Generation X or Y. Look for alternatives that fit their well-being while still maintaining a standard return to work program." Louis Southworth, Jackson & Kelly, presented for the 14th straight year a synopsis of the activities and issues that are affecting the legislative process, including a projected budget deficit of nearly \$150 million for the next fiscal year budget. "The State has its biggest budget challenge in recent years due to declining coal severance tax collections and competition from other states allowing gaming operations. The budget will dominate this session," Southworth predicted. Marc Monteleone, chairman of the WV Design-Build Board, lead a panel discussion with fellow board member, John Goetz, and contractors Ed Phares and Mike Davis, on what works and doesn't work as it relates to the design-build method of construction on public projects. Matthew Bourne, CAWV Education Committee chairman, unveiled the CAWV's new educational programs. "We have developed a series of educational programs designed for the company president to the worker on the job," Chairman Bourne said. "Many of these programs will be web-based so they can be archived and viewed any time of the day." He also outlined the "Simulated Workplace" program with West Virginia schools.

At the Tuesday business session, Tracy Webb, Deputy Attorney General, gave members an idea of how state contracts are reviewed and approved by the Attorney General. "The AG's office reviews every state contract before the State Purchasing Division signs a contract with a contractor or vendor," she said. Mrs. Webb said her office is making sure contracts are turned

around quickly and gave members an idea of what holds up approval of contracts, such as if terms of the contract are different from the general conditions or insurance limits are not appropriate. Tim George, Brown Edwards and Company, provided members with the tax implications of implementing ObamaCare. "Employers are going to have to document their programs extensively or risk them not being tax deductible," George said. He also said the Cadillac programs are a bigger issue than what the Obama Administration is saying. "This will affect many, many existing plans." David Lanham and Sean Mayberry of Lanham O'Dell and Company provided a 2014 financial outlook and what investors need to consider when making investment decisions this year. Pat McDonald, CAWV's director of member services, outlined the many money saving programs available to members through their CAWV and AGC of America membership. These include Enterprise, Fastenal, Verizon Wireless and Ford.

"Everyone I spoke with thought this was a very successful meeting," said CAWV President Phil Weser, March-Westin Company, Inc., Morgantown. "I was glad Matthew Bourne and the Education Committee have developed an innovative continuing education curriculum for the membership. With the support of BrickStreet, the CAWV will help our members better address the challenges and complexities of our ever-changing construction environment. I'm pleased the association will be able to teach technology with technology and this year's meeting attendees got to see what's to come. I look forward to all members learning about our new educational programs," the president said.

A number of social events and banquets were interspersed with the business sessions to give members an opportunity to network and renew friendships. The Prayer Breakfast featured an inspirational message from Rev. Ronald Walker of the Word of Light Christian Center in St. Thomas. 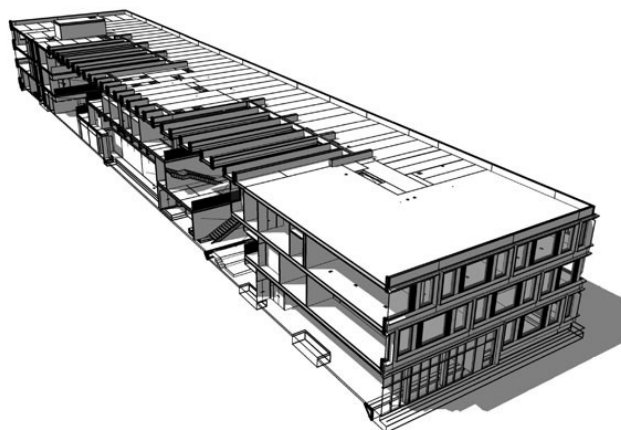

BUILDING DIVISION MEETS AT THE CAWV MIDYEAR MEETING

The CAWV Building Division met at the Midyear Meeting held January 24-29, at The Marriott Frenchman's Reef Resort. Building Division Chairman Jamie Ridgeway, March-Westin Company, reported that several CAWV Task Forces have been busy working on industry issues over the past several months. The Buy American Legislation was discussed at length. CAWV President Phil Weser urged all building division members to read the legislation and to watch for Legislative Updates from the CAWV. He asked that Building Division members get involved by calling delegates to let them know you oppose this legislation. Attendees also received an update on the CAWV / School Building Authority of West Virginia (SBA) Task Force. That task force continues to meet regularly to work on issues related to school construction projects. At the latest meeting, the SBA announced it plans to implement Building Information Modeling (BIM) on all its projects sometime in 2015. The SBA Task Force will continue to meet to discuss ways that the technology can be implemented on school projects without becoming a burden to all parties involved.

MARK MANCHIN TO LEAVE SCHOOL BUILDING AUTHORITY

Lockout Tagout

Anyone who operates, cleans, services, adjusts and repairs machinery or equipment should be aware of the hazards associated with that machinery. Any powered machinery or electrical equipment that can move in a way that would put people in danger is a hazard that can be prevented by following locking or tagging procedures. Failure to lock out or tag power sources on equipment can result in electrocutions, amputations and other serious-sometimes fatal-accidents.

What are the most common causes of these accidents?

- The machine or piece of equipment was not completely shut off before a maintenance or repair operation. Not only must the machine be turned off but also the power source that goes to it.
- The machine was turned on accidentally, either out of carelessness or because the person who turned it on didn't realize that another worker was there and could get hurt.
- The machine wasn't working correctly but wasn't fixed, turned off, locked or tagged, and someone who didn't know about the problem used it.
- Moving equipment wasn't blocked.
- Safety procedures were inadequate or hadn't been properly explained.

Remember the dangers and be on your guard around any machinery and moving equipment. Even if you don't operate the machinery, you could get caught in it and injured if it isn't properly disconnected. So what can you do to prevent accidental injury from moving machinery?

- Ensure you know the hazardous energy associated with your equipment prior to doing any work on it.
- Ensure you know all the energy that could affect the task (electric, gravity, water, pneumatic, hydraulic, steam, etc.)
- Ensure you control the accidental release of the energy prior to working on the equipment through lockout, tagout or alternative measures identified for your specific equipment.
- Never reach into moving equipment. In even the blink of an eye you could have a life changing injury.
- Test the energy after you believe it to be isolated. This is one of the most overlooked steps and probably the most important. Employees think they have isolated the energy at the source, but it isn't for one reason or another.
- Be aware of your personal safety and the safety of others when working with or around moving equipment and machinery. Always follow proper lockout and tagout procedures, even for a quick or minor repair!

UTILITY DIVISION MEETS AT THE CAWV MIDYEAR MEETING

The CAWV Utility Division met on Sunday, January 25, at the Marriott Frenchman's Reef Resort in St. Thomas, in conjunction with the CAWV Midyear Meeting. Members attending the meeting discussed several industry issues. Scott Pierson, Pipe Plus, who chaired the meeting, presented a report from the WV Infrastructure and Jobs Development Council (WVIJDC). The report details the amount of funds, currently \$108,921,764, the WVIJDC has in its accounts and is not committed to funding projects. That amount is divided into the three congressional districts and the majority of the funds are designated to be used as low interest loans for projects. Recently Governor Tomblin proposed that \$20 million in funds be taken from WVIJDC for the next three years to help balance the state budget. "Utility Division Members need to contact their legislators to let them know that they are opposed to removing any funding from the WVIJDC that would affect the amount available for water and sewer projects" said Mr. Pierson. The CAWV will continue to update members on this issue through the Legislative Bulletin.

Division members also discussed the difficulty in obtaining waste permits on some utility projects. Mr. Pierson reported that the Joint Utility Committee has appointed Tim Spradling, Rover Construction, and James Scott Pierson, Pipe Plus, to represent the utility industry on a task force that was recently created by CAWV Joint Cooperative Committee to work with West Virginia Department of Environmental Protection on waste permit issues. Updates on the progress of the task force will be reported at the next Joint Utility Committee meeting.

All of these issues will be discussed and updated at the next meeting of the Joint Utilities Committee on Thursday, February 20, at 10:00 a.m. in the conference room at the CAWV

EPA AGREES TO ISSUE COAL ASH RULES

As part of a settlement agreement related to a federal lawsuit, U.S. EPA last week agreed to take "final action" on coal ash waste disposal rules by December 19, 2014. The lawsuit was initiated in 2012 by environmental groups that were pushing EPA to expedite a rulemaking on the issue. AGC has been working to keep EPA from taking action to deem coal ash (including fly-ash) as hazardous. AGC submitted comments urging EPA to weigh the potential impacts of its regulatory options on the beneficial use of these materials and take into consideration the real environmental benefits of reusing these materials, as well as the lack of negative reports (i.e., alleged or proven damage cases) associated with the beneficial use of fly-ash in many construction applications including concrete and wallboard. AGC urged EPA to either rely on state requirements or establish non-hazardous waste requirements that protect the beneficial use of fly-ash in construction.

AGC is also working in support of HR 2218 the "Coal Residuals Reuse and Management Act of 2013," which was sponsored by Rep. David McKinley (R-W.Va.) and a bipartisan group of representatives. The legislation would prevent the EPA from regulating coal ash as a "hazardous" substance. The legislation would give states broad powers to regulate the disposal of waste from coal combustion as long as they follow minimum federal standards. HR 2218 has been reported from the House Commerce Committee and is pending floor action. Companion legislation has not yet been introduced in the Senate.

STATE OF UNION CALLS FOR TRANSPORTATION AUTHORIZATION OFFERS NO SOLUTION

As he has done in the past, President Obama used his State of the Union address to show his support for infrastructure without offering any concrete ways to responsibly pay for the investments needed for the nation's aging roads, bridges, ports, airports, waterways, and water systems. While the president did call on Congress to complete action on the pending surface transportation reauthorization bill and water resources bill, he offered no new funding ideas on how to address our nation's long-term infrastructure needs. He pointed to corporate tax reform as the way to "create jobs rebuilding our roads, upgrading our ports, and unclogging our commutes." However, Republicans in Congress agree that any tax reform effort should be revenue-neutral and that eliminating deductions and preferences should only be used to lower the rates for all businesses and not for unrelated spending.

AGC issued a statement in response to the State of the Union and looks forward to the administration's fiscal year 2015 budget proposal, which will hopefully provide more details on how to provide the investment necessary to responsibly deal with pressing infrastructure needs, including addressing the revenue shortfall facing the Highway Trust Fund. Two of AGC's top legislative priorities are passing a water resources bill and fixing the Highway Trust Fund. We encourage AGC chapters and members to visit our Legislative Action Center and contact their members of Congress to ask them to complete work on WRDA and address the revenue problems facing the Highway Trust Fund.

U.S. DOT STUDY SAID TO SUPPORT TRUCK DRIVER HOUR LIMIT RULE

The Federal Motor Carrier Safety Administration (FMCSA) released a study last week that it claims supports the restart provision in FMCSA's current hours-of-service rule as more effective at combating fatigue than the prior hours rule. The hours of service rule, which became effective July 1, requires any driver working long enough to need a restart to take off at least 34 consecutive hours that include two periods between 1 a.m. and 5 a.m. FMCSA said the study found that drivers who began their work week with just one nighttime period of rest, as compared with the two nights in the updated 34-hour restart break, exhibited more lapses of attention, reported greater sleepiness and showed increased lane deviation in the morning, afternoon and at night.

The study was mandated by MAP-21 which called for the agency to present scientific evidence that the restart provision helps truck drivers stay alert. Rep. Richard Hanna (R-N.Y.), a longtime opponent of the restart change said, "This half-baked study only underscores the need to legislatively delay the rule and have the Government Accountability Office (GAO) conduct an independent analysis of the study so we can get a credible account of what this rule will truly mean for the safety of truckers, commuters and businesses." Rep. Hanna has proposed legislation to repeal the restart changes until GAO can assess them.
